- 4.3 Describe the influence of species-specific ethology on behavioural presentations of confrontation and repulsion
- 4.4 Describe general and specific approaches to cases where repulsion or confrontational behaviours are being demonstrated toward owners, familiar and unfamiliar dogs or cats and unfamiliar people

- 6.2 Describe the relationship between fear-anxiety and pain emotional motivations and the influence of pain on companion animal behaviour
